

PAC-B TV Content Submission and Liability Agreement

By submitting materials for broadcast on **Baldwinsville PAC-B TV** ("PAC-B TV"), I ("the Submitter") acknowledge and agree to the following terms:

1. **Responsibility and Ownership**

I am solely responsible for the content of any material I submit for broadcast, including but not limited to video, audio, graphics, or written elements ("Program Material"). I affirm that I am the rightful owner of, or have obtained all necessary licenses, permissions, and clearances for, all intellectual property, music, images, performances, and any other material included in my submission.

2. **Compliance with Laws**

I warrant that my submission complies with all applicable local, state, and federal laws and regulations, including but not limited to copyright, trademark, privacy, and defamation laws. I understand that **commercial or promotional programming for for-profit entities is not permitted** and that **advertising or marketing content** will not be accepted for broadcast.

3. **Indemnification and Hold Harmless Clause**

I agree to indemnify, defend, and hold harmless **Baldwinsville PAC-B TV**, its directors, officers, employees, staff, and volunteers from and against any and all claims, damages, liabilities, costs, and expenses (including reasonable attorney's fees) arising out of or related to:

- The broadcast, distribution, or use of my Program Material by PAC-B TV;
- Alleged or actual infringement of any copyright, trademark, or other proprietary right;
- Claims of libel, slander, defamation, invasion of privacy, or violation of publicity rights;
- Any failure to comply with applicable laws or regulations.

4. I understand that PAC-B TV does **not** pre-screen or edit submissions and therefore assumes **no responsibility or liability** for the content, accuracy, or legality of any submitted materials.

5. **Broadcast Rights**

By submitting my Program Material, I grant PAC-B TV a non-exclusive, royalty-free license to broadcast, stream, and otherwise distribute the material on cable television, the internet, or any related media platforms. This license includes the right to make technical modifications as necessary for broadcasting purposes.

6. **Program Content Liability**

I acknowledge that I bear **full responsibility** for the consequences of the broadcast or distribution of my Program Material. PAC-B TV is not liable for any claims or damages resulting from the airing, publication, or dissemination of the material provided by me.

7. **Recorded Media Disclaimer**

I understand that PAC-B TV is not responsible for damage to any physical or digital media submitted or retained for broadcast purposes. I agree to retrieve any submitted recorded media within **30 days** of submission. Materials not retrieved within this period may be **disposed of at PAC-B TV's discretion** without notice or liability.
